FEES AND CHARGES FROM 1ST APRIL 2021

Interment of a Body in a Purchased Grave	
Under two years of age	NO CHARGE
Between two and ten years	£72.00
Over ten years of age (<i>at a depth of not more than six feet 6 inches</i>)	£445.00**

Interment of Cremated Remains	
At a depth of not more than three feet	£175.00**

Walled Graves	
For the right to construct a Walled Grave (for each grave space)	POA
NOTE: <i>This fee is additional to the fee for the purchase of a grave space and in addition to the Interment fee</i>	

Purchase of a Grave Space	
Single Grave Space (9 feet by 4 feet) - (Adults)	£290.00
Single Grave Space (5 feet by 3 feet) - (Children) Section V	£77.00
Single Grave Space (4 feet by 2 feet) - (Cremated Remains) - Section Q	£105.00

****An additional fee of £31.00 will be charged for the change of ownership of the Exclusive Rights of Burial, where the grave owner has deceased, upon completion of a Re-Assignment of Ownership form**

Additional Inscriptions	
In respect of each additional inscription after the first on any stone, monument or memorial	£42.00

Inscriptions on Memorial Wall	
For each inscription of one line containing not more than 22 characters	£125.00
For each additional line containing not more than 22 characters	£125.00

Miscellaneous Charges	
Use of Cemetery Chapel	£125.00
Certified Extracts from the Register of Burials	£16.00
Searches in the Register of Burials:- For the first hour For each additional hour	£21.00 £18.00
Transfer of Exclusive Right of Burial / Certified Copies of Exclusive Right of Burial	£31.00

Anyone can purchase a grave in the Town of Rushden but prices are higher for non-residents.

To qualify for resident prices, you must be:-

- A resident yourself;
- Or the nearest surviving relative purchasing a grave for someone who was a resident of the Town of Rushden;
- Non-residents will be charged double fees.
